The Department for Enterprise, after consultation with the Secretary of State¹, makes the following Order under section 11 of the Airports and Civil Aviation Act 1987.

1 Title

This Order is the Civil Aviation Acts (Application) (Amendment) Order 2019.

2 Commencement

If approved by Tynwald², this Order comes into operation on 25 March 2019.

3 Amendment of the Civil Aviation Acts (Application) Order 2006

 - (c) any other instrument applied to the Isle of Man under section 11 or 11A of the Airports and Civil Aviation Act 1987 (an Act of Tynwald); or
 - (d) any instrument made under section 11B of the Airports and Civil Aviation Act 1987 (an Act of Tynwald).

EXPLANATORY NOTE

(*This note is not part of the Order*)

This Order amends section 11 of the Civil Aviation Act 1982 (an Act of Parliament) (charges) as it was applied in modified form to the Island by the Civil Aviation Acts (Application) Order 2006.

The amendments made by this Order will allow for charges to be made for functions of the Department for Enterprise under sections 11A and 11B of the Airports and Civil Aviation Act 1987 and Part 2 of the Aviation Security Act 1987 (an Act of Parliament) (as applied to the Island).

The Order also amends the applied provision which requires the Department for Enterprise to publish a scheme of charges before the scheme comes into force, by reducing the timescale for so doing to 14 days.
