



## ROAD TRAFFIC REGULATION ACT 1985

### **BIBALOE BEG (ESKADALE) ROAD (ONCHAN) (TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2011**

*Coming into Operation: 7 February 2011*

The Department of Infrastructure makes this Order under section 3 of the Road Traffic Regulation Act 1985<sup>1</sup>.

**1 Title**

This Order is the Bibaloe Beg (Eskadale) Road (Onchan) (Temporary Prohibition of Through Traffic) Order 2011.

**2 Commencement**

This Order comes into operation at 6.00am on 7 February 2011.

**3 Temporary closure of road to through traffic**

No person must except upon the direction or with the permission of a police constable in uniform cause or permit any vehicle to proceed on that section of Bibaloe Beg (Eskadale) Road, Onchan, between its junction with King Edward Road and the property 'Highfield'.

**4 Exemptions**

Article 3 does not apply to a vehicle requiring access to premises or land adjacent to the road specified in article 3 or to—

- (a) a vehicle engaged in any of the following operations—
  - (i) works in land or premises adjacent to the road specified in article 3;
  - (ii) works in the road specified in article 3 authorised by statutory provisions; or

- (iii) in the service of a local authority or the Department of Infrastructure in pursuance of any statutory functions in the road or in adjacent land or premises if it cannot conveniently be used for such purposes on any other road;
- (b) a vehicle being used in the course of duty for the police, fire brigade, ambulance or coastguard service;
- (c) a vehicle for which the driver holds a permit issued by the Department of Infrastructure for its use in the road, at a time or for a purpose specified in the permit; or
- (d) such vehicular traffic as may be authorised by the Department of Infrastructure.

**5 Duration**

This Order will continue in force from 6.00am on 7 February 2011 until 6.00pm on 9 February 2011 or until the sewer pipe and ducting work is completed, whichever is the earlier.

**EXPLANATORY NOTE**

*(This note is not a part of the Order)*

The effect of this Order is to prohibit through vehicular traffic from proceeding on that section of Bibaloe Beg (Eskadale) Road, Onchan, between its junction with King Edward Road and the property 'Highfield', whilst sewer pipe and ducting work takes place.

Properties on Bibaloe Beg (Eskadale) Road can be accessed via the Whitebridge Road end.

Alternative routes will be via Whitebridge Road and King Edward Road.
