



HIGHWAYS ACT 1986

A17 SULBY BRIDGE TO BRIDE ROAD, ST JUDES (ANDREAS) (TEMPORARY CLOSURE) (NO 2) ORDER 2011

Coming into Operation: 7 March 2011

The Department of Infrastructure makes this Order under section 38 of the Highways Act 1986¹.

- 1 Title**
This Order is the A17 Sulby Bridge to Bride Road, St Judes (Andreas) (Temporary Closure) (No 2) Order 2011.
- 2 Commencement**
This Order comes into operation at 6.00am on 7 March 2011.
- 3 Temporary closure of road to vehicular and pedestrian traffic**
No person must except upon the direction or with the permission of a police constable in uniform proceed or cause any vehicle to proceed on that section of the A17 Sulby Bridge to Bride Road, St Judes, Andreas from its junction with the St Judes crossroads to its junction with the lane leading to Craig Farm.
- 4 Exemptions**
Article 3 does not apply to a person or vehicle requiring access to premises or land adjacent to the road specified in article 3 or to—
 - (a) persons or vehicles engaged in any of the following operations—
 - (i) works in land or premises adjacent to the road specified in article 3;
 - (ii) works in the road specified in article 3 authorised by statutory provisions; or

- (iii) in the service of a local authority or the Department of Infrastructure in pursuance of any statutory functions in the road or in adjacent land or premises if it cannot conveniently be used for such purposes on any other road; or
- (b) persons or vehicles being used in the course of duty for the police, fire brigade, ambulance or coastguard service;
- (c) persons holding a permit issued by the Department of Infrastructure for its use in the road, at a time or for a purpose specified in the permit; or
- (d) such vehicular traffic as may be authorised by the Department of Infrastructure.

5 Duration

This Order is in force from 6.00am on 7 March 2011 until 6.00pm on 1 April 2011 or until Phase II of the water mains laying work is completed, whichever is the earlier.

EXPLANATORY NOTE

(This note is not a part of the Order)

The effect of this Order is to prohibit vehicular and pedestrian traffic from proceeding on a section of the A17 Sulby Bridge to Bride Road, St Judes, Andreas from its junction with St Judes crossroads to its junction with the lane leading to Craig Farm, whilst Phase II of the water mains laying work takes place.

Access to properties will be maintained.

An alternative route will be via the B14 Bernahara (Bayr Ny Harrey) Road or the A14 Jurby Road.
