THE CIVIL AVIATION (CHARGES) SCHEME 2011

Approved by Tynwald

12th April 2011

Coming into operation

1st May 2011

The Department of Economic Development, after consulting the Treasury, makes this Scheme under section 11 of the Civil Aviation Act 1982 (an Act of Parliament)¹ as it has effect in the Isle of Man².

1. Title

The title of this Scheme is the Civil Aviation (Charges) Scheme 2011.

2. Commencement

If approved by Tynwald this Scheme shall come into operation on the 1st May 2011.

3. Interpretation

In this Scheme —

- (a) "the Act" means the Civil Aviation Act 1982 (an Act of Parliament);
- (b) "the 2005 Order" means the Air Navigation Order 2005³;
- (c) "the 2007 Order" means the Air Navigation (Isle of Man) Order 2007⁴;
- (d) "the Department" means the Department of Economic Development;
- (e) expressions used in the 2005 Order, the 2007 Order or the Mortgaging of Aircraft Order 1972⁵ have the same meanings as in the Order in question;
- (f) any reference to an instrument or provision applied to the Isle of Man under section 11 of the Airports and Civil Aviation Act 1987⁶ shall be

construed as a reference to that instrument or provision as it has effect in the Isle of Man.

4. Charges

- (1) In respect of the performance of any function of the Department specified in column 1 of the Schedule, there shall be paid to the Department the corresponding charge specified in column 2 of the Schedule.
- (2) Subject to paragraph (3), a charge specified in paragraph (1) shall be paid to the Department by the applicant at the time of application for the matter in question, except where arrangements between the Department and the applicant are in force for payment of charges on credit.
- (3) Where a charge is payable in accordance with Part 6 of the Schedule —
 - (a) there shall in addition be paid to the Department a charge equal to the actual expenses reasonably incurred in carrying out the preparatory work, investigation or inspection in question, including, but not limited to, transport, accommodation and subsistence;
 - (b) the charges shall be paid to the Department on demand (subject to any arrangements in force between the Department and the applicant for payment of charges on credit).

5. Revocation

The Civil Aviation (Charges) Scheme 2007⁷ is revoked.

6. Transitional provision

Nothing in this Scheme applies in relation to anything to be done or issued by the Department pursuant to an application made before the 1st May 2011.
