



EUROPEAN COMMUNITIES (ISLE OF MAN) ACT 1973

BELARUS SANCTIONS REGULATIONS 2011

Laid before Tynwald 12 April 2011
Coming into operation in accordance with regulation 2

The Council of Ministers makes these Regulations under section 2B of the European Communities (Isle of Man) Act 1973¹.

1 Title

These Regulations are the Belarus Sanctions Regulations 2011.

2 Commencement

These Regulations come into operation immediately after they are made.

3 Amendment of the Belarus Sanctions (Freezing of Funds, Etc) Regulations 2006

- (1) In regulation 1(2) of the Belarus Sanctions (Freezing of Funds, Etc) Regulations 2006² ("the 2006 Regulations") for the definition of "the EC Regulation" substitute—

""the EC Regulation" means Council Regulation (EC) No 765/2006 of 18 May 2006 concerning restrictive measures against President Lukashenko and certain officials of Belarus³, as it has effect in the Island, as amended by—

- (a) Council Regulation (EC) No 646/2008⁴ of 8 July 2008 amending Regulation (EC) No 765/2006 concerning restrictive measures against President Lukashenko and certain officials of Belarus; and
- (b) Council Implementing Regulation (EU) No 84/2011⁵ of 31 January 2011 amending Council Regulation (EC) No 765/2006 concerning restrictive measures against President Lukashenko and certain officials of Belarus,

as these Council Regulations⁶ have effect in the Island.”.

- (2) In regulation 2(2)(b) of the 2006 Regulations, for “Article 5(3)” substitute “Article 5(2)”.

EXPLANATORY NOTE

(This Note is not part of the Regulations)

These Regulations amend the Belarus Sanctions (Freezing of Funds, Etc) Regulations 2006 (“the 2006 Regulations”) to take account of the amendment of Council Regulation (EC) No 765/2006 of 18 May 2006 concerning restrictive measures against President Lukashenko and certain officials of Belarus (which was applied to the Island, with modifications by SD 496/06) by Council Regulation (EC) No 646/2008 and Council Implementing Regulation (EU) No 84/2011 (which were applied to the Island, with modifications, by the European Union (Belarus Sanctions) (Application) (Amendment) Order 2011 (SD 136/11)).

The 2006 Regulations, as amended, provide for offences and penalties for breaches of the EU legislation concerning restrictive measures against President Lukashenko and certain officials of Belarus as it applies in the Island.
