



ROAD TRAFFIC REGULATION ACT 1985

A24 MINES ROAD, FOXDALE (PATRICK) (TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2011

Coming into Operation: 14 March 2011

The Department of Infrastructure makes this Order under section 3 of the Road Traffic Regulation Act 1985¹.

- 1 Title**

This Order is the A24 Mines Road, Foxdale (Patrick) (Temporary Prohibition of Through Traffic) Order 2011.
- 2 Commencement**

This Order comes into operation at 9.15am on 14 March 2011.
- 3 Temporary closure of road to through traffic**

No person must except upon the direction or with the permission of a police constable in uniform cause or permit any vehicle to proceed on that section of the A24 Mines Road, Foxdale, Patrick from its junction with the A3 Main Road to its junction with Kionslieu Hill, on the days and at the times specified in the Schedule.
- 4 Exemptions**

Article 3 does not apply to a vehicle requiring access to premises or land adjacent to the road specified in article 3 or to—

 - (a) a vehicle engaged in any of the following operations—
 - (i) works in land or premises adjacent to the road specified in article 3;
 - (ii) works in the road specified in article 3 authorised by statutory provisions; or

- (iii) in the service of a local authority or the Department of Infrastructure in pursuance of any statutory functions in the road or in adjacent land or premises if it cannot conveniently be used for such purposes on any other road;
- (b) a vehicle being used in the course of duty for the police, fire brigade, ambulance or coastguard service;
- (c) a vehicle for which the driver holds a permit issued by the Department of Infrastructure for its use in the road, at a time or for a purpose specified in the permit;
- (d) a public passenger vehicle that is constructed or adapted to carry more than 16 passengers in addition to the driver; or
- (e) such vehicular traffic as may be authorised by the Department of Infrastructure.

5 Duration

This Order is in force from 9.15am on 14 March 2011 until 3.15pm on 13 May 2011 or until the footway reconstruction and carriageway resurfacing works are completed, whichever is the earlier.

The effect of this Order is to prohibit through vehicular traffic from proceeding on that section of the A24 Mines Road, Foxdale, Patrick from its junction with the A3 Main Road to its junction with Kionslieu Hill, whilst footway reconstruction and carriageway resurfacing works take place.

Access to properties will be maintained.
