



ROAD TRAFFIC REGULATION ACT 1985

U92 MAUGHOLD MOUNTAIN ROAD AND U21 CLARUM ROAD (MAUGHOLD AND LONAN) (TEMPORARY PROHIBITION OF VEHICULAR TRAFFIC) ORDER 2011

Coming into Operation: 1 April 2011

The Department of Infrastructure makes this Order under section 3 of the Road Traffic Regulation Act 1985¹.

1 Title

This Order is the U92 Maughold Mountain Road and U21 Clarum Road (Maughold and Lonan) (Temporary Prohibition of Vehicular Traffic) Order 2011.

2 Commencement

This Order comes into operation at 6.00am on 1 April 2011.

3 Temporary closure of road to vehicular traffic

No person must except upon the direction or with the permission of a police constable in uniform cause or permit any vehicle to proceed on the U92 Maughold Mountain Road and U21 Clarum Road between Glen Mona, Maughold at grid reference 453887, and leading westwards to Slieau Lhean and then south-eastwards to Ballaragh, Lonan at grid reference 449853.

4 Exemptions

Article 3 does not apply to a vehicle requiring access to premises or land adjacent to the road specified in article 3 or to—

- (a) a vehicle engaged in any of the following operations—
 - (i) works in land or premises adjacent to the road specified in article 3;

- (ii) works in the road specified in article 3 authorised by statutory provisions; or
 - (iii) in the service of a local authority or the Department of Infrastructure in pursuance of any statutory functions in the road or in adjacent land or premises if it cannot conveniently be used for such purposes on any other road;
- (b) a vehicle being used in the course of duty for the police, fire brigade, ambulance or coastguard service;
 - (c) a vehicle for which the driver holds a permit issued by the Department of Infrastructure for its use in the road, at a time or for a purpose specified in the permit; or
 - (d) such vehicular traffic as may be authorised by the Department of Infrastructure.

5 Duration

This Order is in force from 6.00am on 1 April 2011 until 6.00pm on 1 October 2011 or until the track reinstatement related works are completed, whichever is the earlier.

EXPLANATORY NOTE

(This note is not a part of the Order)

The effect of this Order is to prohibit vehicular traffic from proceeding on the U92 Maughold Mountain Road and U21 Clarum Road, between Glen Mona in Maughold and Ballaragh in Lonan, whilst track reinstatement related works take place.

This Order is an extension to a previous temporary Order.
